



LIMITED PRODUCT WARRANTY SABIAN SOUND KIT PRODUCTS



The SABIAN® Limited Warranty applies only to new SABIAN products purchased by the original retail consumer living in the United States from an authorized SABIAN Dealer in the United States. SABIAN products purchased by a consumer living outside the United States from a U.S. SABIAN Dealer or a U.S.-based website are NOT covered under the terms of this limited warranty. Products purchased outside the United States are subject to country-specific warranties. Contact the SABIAN International Distributor in your country for details.

This warranty applies to the original purchaser only and is not transferable.

WHAT IS COVERED?

SABIAN LTD, Inc. warrants the PDMr mixer to be free of defects in material and workmanship for a period of one (1) year from the original date of purchase. (90 days) for external power supplies and for SABIAN microphones.

WHAT IS NOT COVERED?

This warranty is subject to the following conditions and exclusions: Defects caused by wear and tear, misuse or neglect are not covered by this warranty.

This warranty will be void if:

- a. The unit has been altered or modified.
- b. The serial number has been removed or defaced.
- c. Original purchase is not from an Authorized SABIAN Dealer.
- d. Improper operation of the unit.
- e. Lightning or Power surges

This warranty is for SABIAN products only. Any service claims resulting from other brands used in conjunction with SABIAN products will not be allowed or honored.

WHERE DO I GO?

All warranty service must be performed by SABIAN LTD, or by an Authorized SABIAN Service Center. Service Centers are listed at www.SABIAN.com.

All component replacement costs will be assumed by SABIAN within the warranty period. The labor costs will be covered by SABIAN according to established current rate schedules. Transportation to and from the warranty center is the sole responsibility of the purchaser. SABIAN assumes no liabilities for damages incurred in transit to or from the service center.

WHAT DO I DO?

If warranty repairs become necessary, the owner is responsible for delivery of the unit to an Authorized SABIAN Service Center. If return is to be made to SABIAN LTD or our central service center, customer must first obtain a Return Authorization from SABIAN's Service Department by telephone or mail. After receipt of a Return Authorization, the owner must ship the unit with a copy of the original sales receipt and a detailed description of the needed repairs. Please include your Return Authorization number on all correspondence. Repaired products will be returned freight collect. SABIAN will, at its option, repair or replace defective parts or products.

LIMITATION OF WARRANTY:

SABIAN SHALL NOT BE LIABLE UNDER ANY CIRCUMSTANCES FOR CONSEQUENTIAL, SPECIAL OR INCIDENTAL DAMAGES RESULTING FROM ANY DEFECT IN OR FAILURE OF SABIAN PRODUCTS. SABIAN'S LIABILITY AND YOUR REMEDY FOR DAMAGES AGAINST SABIAN SHALL NOT EXCEED THE AMOUNT OF THE PURCHASE PRICE OF THE SABIAN PRODUCT.

The above limitations or exclusions shall be limited to the extent they violate the laws of any particular state.
